Terms and Conditions for Vodafone Fan Message on Lift Kara De (hereinafter referred to as "Service"):

This service is available to cellular mobile subscribers (Subscribers) of Vodafone Essar Limited, Vodafone Essar Mobile Services Limited, Vodafone Essar South Limited, Vodafone Essar Gujarat Limited, Vodafone Essar East Limited, Vodafone Essar Digilink Limited, Vodafone Essar Cellular Limited, Vodafone Essar Spacetel Limited (collectively as "Vodafone Essar") in their respective telecom service areas subject to the terms and conditions of Service herein below.

Standard tariff of Rs.6/- per minute is applicable for calling Vodafone short code 56789 will be applicable.

Vodafone Fan Message

Lift Karade is a talk show featuring Karan Johar as the host who will talk to various celebrities ("Stars"). Sony TV will air the said talk show on television channel Sony TV every Fri – Sat 20:00 hrs – 21:00 hrs.

Subscribers have the opportunity to record their message for the Stars through Vodafone short code 56789 by using their Vodafone number. The best message will be played to the Stars on TV in the said talk show. Reaction of the Stars on selected best message can be seen on the said Talk show and name of the Subscriber who's message is selected as best message will be announced and/or displayed in the said talk show.

Process

Subscribers can call 56789 (Rs 6/min) and choose the relevant branch/option of the IVR to record their message. On the IVR, the Subscribers will also need to choose the Star for which he/she wants to record the message. The recorded messages will be passed on to Sony TV and they will choose the best message for airing.

Alternately, Subscribers can also go to a Vodafone Store and leave a recording of their message on a CD, which will be also sent to Sony TV.



Terms and Conditions:

Subscribers understand that Vodafone Essar has no role to play in the selection of best messages and this is mere service available through short code to pass on the messages to Sony TV.

Vodafone Essar reserves the right to change / modify the Service or terms and conditions of the Service, including but not limited to cancellation or suspension of the Service at any time at its own discretion, without assigning any reason. Vodafone Essar shall not be obliged to give any prior notice for aforesaid change / modification / suspension/cancellation.

The Subscribers hereby irrevocably authorize Vodafone Essar, that the data gathered for the Service (including Subscriber name and photograph etc.) shall be the property of Vodafone Essar and Vodafone Essar shall be entitled to use the same in its communications including marketing promotions and advertisements along with/without Vodafone Essar's brand.
